

INFORMATION OBLIGATION "RODO"

In connection with the obligations under RODO*, we inform you that:

1. The administrator of your personal data is Infinity Space Sp. z o.o. based in Warsaw Al. Jana Pawła II 27, 00-867 Warsaw, e-mail: biuro@infinityspace.pl
2. Your personal data shall be processed for the following purposes, on the basis of the following provisions:

Purpose of processing	Legal basis	Data retention period
Execution of agency agreement for the sale/buy/rent/lease of Property and lease management and property advisory services.	Article 6(1)(b) RODO	For the duration of the Agreement
In order to investigate and defend against claims. This is the implementation of the Administrator's legitimate interest.	Article 6(1)(f) RODO	Until the expiry of the limitation periods for civil law claims.
For sending information about new offers and promotions organized by Infinity Space and Partners electronically to the e-mail address indicated in the Agreement.	Article 6(1)(a) RODO	Until you withdraw your consent.
For tax accounting purposes.	Article 6(1)(c) RODO	Until the statute of limitations for the Administrator's tax obligations.
In order to comply with obligations under the Anti-Money Laundering and Countering the Financing of Terrorism Act.	Article 6(i)(c) RODO	For a period of 5 years counting from the first day of the year following the year in which the business relationship was terminated or in which the occasional transaction was carried out - in the case of obligations under anti-money laundering legislation.

3. The Administrator processes the following categories of your personal data: name and surname, PESEL/NIP, home/office address, e-mail address, telephone number.
4. Your personal data will be transferred to the subject with whom you may enter into a cooperation agreement (subcontractor) and to Infinity Space Partners.
5. Other recipients of your data may be entities to whom the Administrator entrusted data processing, e.g. software providers, hosting providers, other cooperating agents, advisers and entities authorized to receive your personal data on the basis of valid legal regulations.
6. If you decide to sell/buy/rent/lease the Property, your personal data will be passed on to the entity with whom you will enter into the sale/buy/rent/lease agreement and the relevant notary (if applicable).
7. You have the right to request access to your personal data from the Administrator, the right to rectification, erasure or restriction of processing, the right to object to processing, the right to data portability.
8. Consent for the sending of commercial and marketing information is voluntary and can be withdrawn at any time, which will not affect the legality of the processing performed on the basis of consent before its withdrawal.

10. You have the right to lodge a complaint with the supervisory authority if you consider that the processing of your personal data does not comply with the RODO.
11. Providing personal data is a statutory requirement and a condition for concluding a contract, and failure to provide data in the scope required by the Administrator may result in refusal to conclude an Agreement.
12. Your data will not be subject to automated decision-making, including profiling.
